

12月美国消费高基数下显示韧性，航空出行人数同比微降 0.1%

本报告导读：

信用卡消费数据显示 25 年 12 月美国服装消费在去年高基数下仍有韧性。25 年 12 月美国航空出行人数同比下降 0.1%，全年表现平稳。迅销公布 FY26Q1 业绩，收入利润均超预期并上调全年指引。

投资要点：

- **投资建议：内需看好三条主线：**①坚定实施扩大内需战略下，建议重点关注估值处历史低位的优质龙头和具备潜在盈利弹性的企业，如安踏体育、李宁、特步国际；②轻奢：客群结构变化叠加产品创意驱动形成结构性增长机会，如普拉达、新秀丽；③低估值高股息：建议关注业绩假设稳健且运营能力较强的企业，关注江南布衣、滔搏、罗莱生活。**出口关注结构性机会**，12 月美国零售数据显韧劲，服装库销比持续降低，结合关税和汇率影响，判断①多元产能布局是重要竞争优势；②订单周期缩短进一步考验企业产线分配能力；③中高端产品订单相对更具韧劲，关注九兴控股、百隆东方、超盈国际控股。
- **信用卡消费数据显示 25 年 12 月美国服装消费在去年高基数下仍有韧性。**根据 SpendTrend 美国信用卡消费数据，2025 年 12 月美国整体零售店同比增长 3.1%，增速环比 11 月（+2.1%）加快；服装配饰店同比增长 3.1%，增速环比 11 月（+3.3%）放缓。2024 年 12 月美国整体零售/服装配饰店增长存在较高基数（分别+6.8%/+9.6%），2025 年 12 月数据表明高基数下美国消费仍有韧性。分品类看：2025 年 12 月男女服装店/鞋店/奢侈品店店同比增长分别 +4.4%/+0.1%/-3.3%，与 11 月（+4.7%/-3.7%/-0.5%）相比，服装与鞋履消费有韧性，奢侈品增速略有放缓。
- **25 年 12 月美国航空出行人数同比下降 0.1%，全年表现平稳。**根据 TSA Checkpoint 数据，2025 年 12 月美国单月航空出行人数共计 7732 万人次，同比下降 0.1%，增速环比 11 月（-0.7%）略有修复。2025 年全年美国累计航空出行人数共计 9.1 亿人次，同比上升 0.2%，2025 年全年表现平稳。根据 IATA 数据，2025 年 11 月全球航空出行 RPK 同比增长 5.7%，环比 10 月（+6.6%）放缓，其中国际/国内 RPK 同比分别增长 7.7%/2.7%，均较 10 月（+8.5%/+3.4%）放缓。
- **迅销公布 FY26Q1 业绩，收入利润均超预期并上调全年指引。**优衣库母公司迅销 FY26Q1（25.9-11）收入 10277 亿日元，同比增长 14.8%，超一致预期 3.8%，环比 25Q4（+6.3%）加速；归母净利 1474 亿日元，同比增长 11.7%，超一致预期 13.3%。期末存货 5461 亿日元，同比增长 6.4%。分地区看，优衣库日本/大中华/亚太/北美/欧洲收入同比分别+12.2%/+7.0%/+22.1%/+30.4%/+34.3%，所有地区均较 25Q4（+6.9%/-9.6%/+10.5%/+22.3%/+31.0%）加速。总体而言去年 10 月转冷、秋装销售较好；日本店同比增长 11.0%、游客消费双位数增长；大中华人民币口径收入同比增长 5.5%，利润实现双位数增长，与京东合作贡献可观电商增量；北美、欧洲店均实现双位数增长，通过杂志宣传与开设旗舰店持续强化消费者心智。公司宣布上调 FY26 全年指引至收入+11.7%/归母净利+3.9%（此前分别+10.3%/+0.5%），预计全年大中华以外所有国际市场双位数增长，优衣库日本收入利润增长（店增长 4%），优衣库大中华收入/利润均正增长。
- **风险提示：**终端消费意愿不及预期，原材料价格波动，行业竞争加剧。

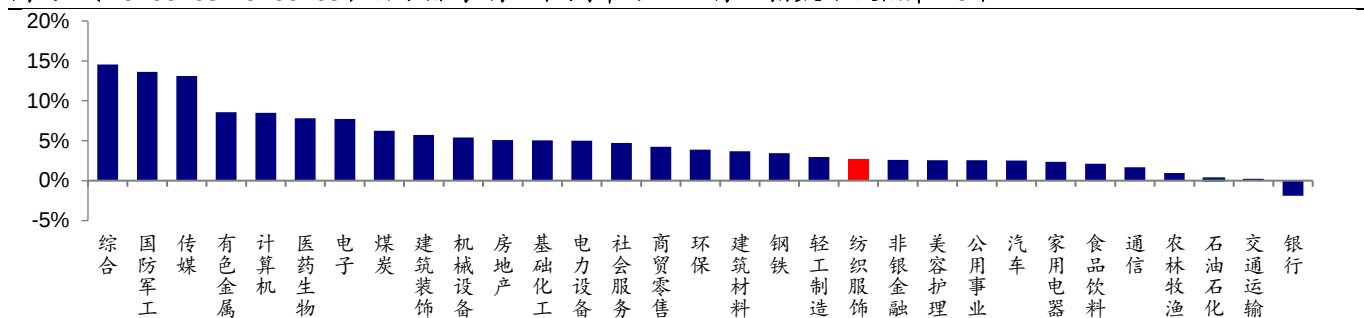

1. 行情回顾

1.1. 上周 A 股市场行情表现

上周（20260105-20260109）申万纺织服饰板块上涨 2.65%，跑输沪深 300 0.13 个百分点，在 31 个申万一级行业中位列 20 位。其中纺织制造板块上涨 2.64%，服装家纺板块上涨 2.64%。个股方面，七匹狼、壹网壹创、太平鸟、ST 步森、联发股份涨幅居前；众望布艺、天创时尚、罗莱生活、欣龙控股、ST 摩登等个股跌幅靠前。从 PE 估值水平来看，纺织服饰板块目前 PE 估值 20.80 倍（TTM，剔除负值，下同），低于历史均值，历史均值为 24.59 倍，其中纺织制造板块 21.12 倍，服装家纺板块 19.85 倍。

1.2. 上周港股市场行情表现

上周恒生指数下跌 0.41%，个股方面，都市丽人、361 度、裕元集团、李宁和晶苑国际涨幅位居前五，分别增长 12.31%、7.99%、7.26%、5.77%和 5.15%；冠城钟表珠宝、千百度、思捷环球、维珍妮和中国动向跌幅位居前五，分别下跌 9.55%、6.94%、5.93%、4.55%和 3.37%。

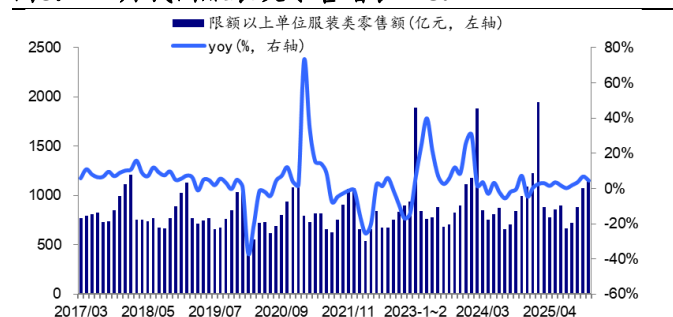

2.1. 11 月我国服装类零售增长 4.5%，纺服出口下降 5.2%

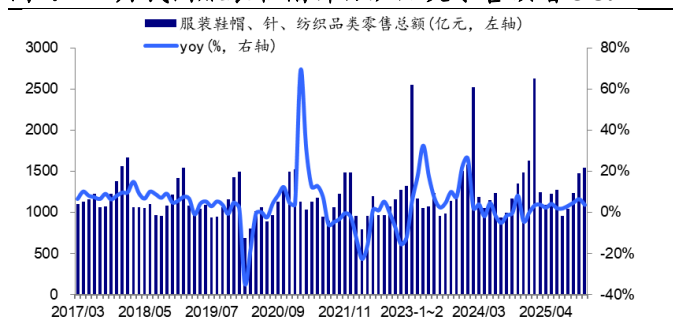
零售数据: 2025 年 11 月, 社会消费品零售总额同比增加 1.30%, 较上年同期增速减少 1.70pct, 我国限额以上单位商品服装类零售额同比增加 4.50%, 较上年同期增速增加 9.00pct, 服装鞋帽、针、纺织品零售额同比增加 3.50%, 较上年同期增速增加 8.00pct。

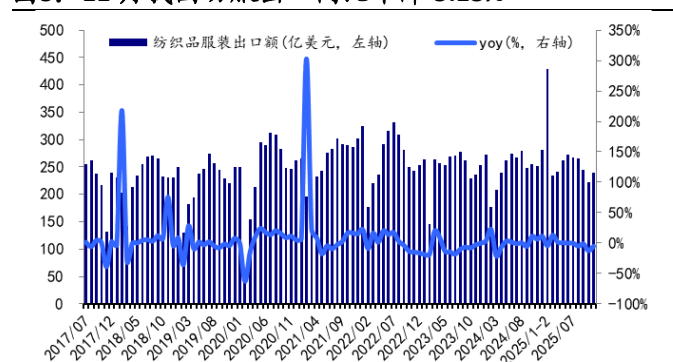
图4: 11 月我国服装鞋帽针纺织品类零售额增 3.5%

出口情况: 2025 年 11 月我国出口纺织品服装约 238.70 亿美元, 同比下降 5.18%, 其中出口纺织纱线、织物及制品 122.80 亿美元、出口服装及衣着附件 115.90 亿美元。1-11 月, 2025 年我国纺织品服装累计出口 2678.00 亿美元, 同比下降 2.10%, 纺织品出口 1300.10 亿美元, 同比增长 0.90%, 服装及其附件出口 1377.90 亿美元, 同比下降 4.40%。上周美元兑人民币汇率下降, 最新汇率为 6.98。

图6: 上周美元兑人民币即期汇率下降



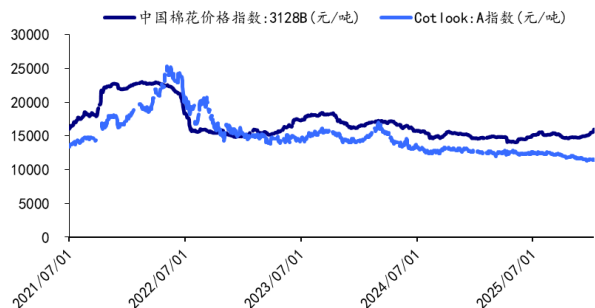

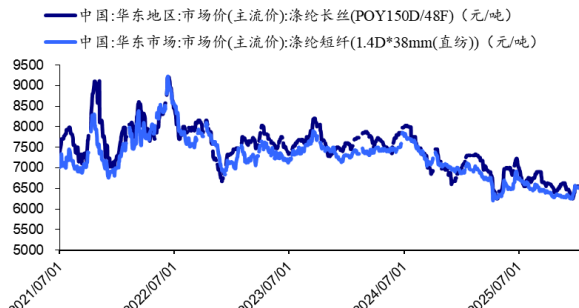

图7：历史国内外棉花价格



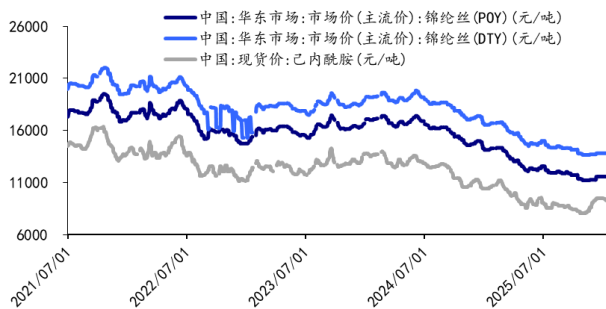

图10：历史布伦特原油期货结算价格



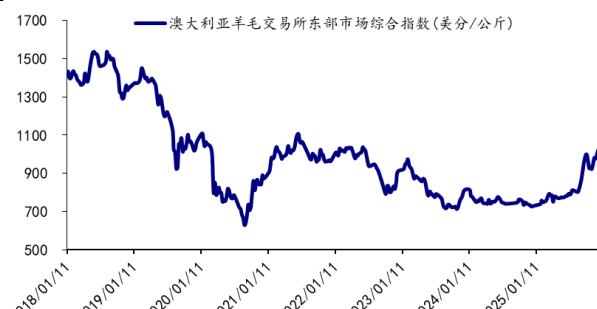

3. 重点公告及新闻

3.1. 公司公告

【梦洁股份-选聘高管】公司选举第八届董事会，董事长姜天武，总经理易浩（姜天武女婿，此前在公司任线下事业部副总经理），财务总监李云龙，聘任吴文文为董秘，吴文文此前任公司证代。原董事陈洁、原董事秦拯、原总经理涂云华、原董秘李军离任。

【健盛集团-终止项目】公司决定终止越南清化年产 6000 万双中高档棉袜和

3000 万件服装项目，因越南清化项目土地出租方其单方面提出将土地使用权证书颁发时间推迟，构成实质性违约。该项目尚在前期土地租赁阶段，未发生资金投入，租赁双方已协商一致解除协议，且均同意互不追究对方任何赔偿责任。本次终止事项不涉及重大资产损失，亦无需计提大额减值准备。

3.2. 行业新闻

【UGG 母公司将精简品牌阵容】

Deckers Brands 集团宣布将于 2026 年初逐步淘汰 Ahnu 与 Koolaburra 的独立产品线与运营，相关交割预计在截至 3 月 31 日的第三季度完成。此举旨在集中资源，加码集团最具增长潜力的核心品牌 Hoka 与 UGG。

【Nike 高管增持股票 对扭亏为盈释放信心】

根据周二提交至美国证券交易委员会（SEC）的监管文件显示，Nike 首席执行官及多位董事近期合计斥资约 445 万美元增持公司股票，向市场释放出管理层对公司业绩复苏的明确信心。该文件显示，Nike 总裁兼首席执行官 Elliott Hill 于周一以每股 61.10 美元的价格购入 16,388 股 B 类普通股，总投入约 100 万美元。

Investment advice: Focus on three main lines of domestic demand: 1) Under the strategy of expanding domestic demand, focus on quality leaders with low valuations and potential profit flexibility, such as Anta Sports Products, Li Ning, Xtep International; 2) Affordable luxury: Structural growth opportunities driven by changes in customer structure and product creativity, such as Prada, Samsonite International; 3) Low valuation, high dividend: Focus on companies with stable performance assumptions and strong operational capabilities, including Jnby Design, null, Luolai Lifestyle Technology. For exports, focus on structural opportunities. December USA retail data shows resilience, with apparel inventory-to-sales ratio decreasing. Considering tariffs and exchange rates, 1) Diversified capacity layout is a key competitive advantage; 2) Shortened order cycles test production line allocation; 3) Mid-to-high-end product orders are more resilient, recommending Stella International Holdings, Bros Eastern, Best Pacific International.

Credit card consumption data shows USA apparel consumption in December 2025 remains resilient despite a high base last year. According to SpendTrend USA credit card consumption data, December 2025 USA overall retail same-store sales grew 3.1% YoY, accelerating from November (+2.1%); apparel accessory stores same-store sales grew 3.1% YoY, slowing from November (+3.3%). December 2024 USA overall retail/apparel accessory stores same-store growth had a high base (+6.8%/+9.6%), December 2025 data shows USA consumption remains resilient. By category: December 2025 men's and women's clothing stores/shoe stores/luxury stores same-store sales were +4.4%/+0.1%/-3.3% YoY, compared to November (+4.7%/-3.7%/-0.5%), apparel and footwear consumption is resilient, luxury growth slightly slowed.

December 2025 USA air travel decreased 0.1% YoY, stable throughout the year. According to TSA Checkpoint data, December 2025 USA monthly air travel was 77.32 million, down 0.1% YoY, slightly recovering from November (-0.7%). Total USA air travel in 2025 was 910 million, up 0.2% YoY, stable throughout the year. According to IATA data, November 2025 global air travel RPK grew 5.7% YoY, slowing from October (+6.6%), with international/domestic RPK growing 7.7%/2.7% YoY, both slowing from October (+8.5%/+3.4%).

Fast Retailing announced FY26Q1 results, exceeding expectations and raising full-year guidance. Uniqlo's parent company Fast Retailing FY26Q1 (Sep-Nov 2025) revenue was 1027.7 billion yen, up 14.8% YoY, exceeding consensus expectation by 3.8%, accelerating from Q4 2025 (+6.3%); NPATs was 147.4 billion yen, up 11.7% YoY, exceeding consensus expectation by 13.3%. Year-end inventory was 546.1 billion yen, up 6.4% YoY. By region, Uniqlo Japan/Greater China/Asia Pacific/North America/Europe revenue grew +12.2%/+7.0%/+22.1%/+30.4%/+34.3% YoY, all accelerating from Q4 2025 (+6.9%/-9.6%/+10.5%/+22.3%/+31.0%). Overall, October's cooling boosted autumn sales; Japan's same-store sales grew 11.0% YoY, tourist consumption grew double digits; Greater China's RMB revenue grew 5.5% YoY, profits grew double digits, with significant e-commerce growth from JD.com collaboration; North America and Europe same-store sales grew double digits, strengthening consumer perception through magazine promotions and flagship stores. The company raised FY26 full-year guidance to revenue +11.7%/NPATs +3.9% (previously +10.3%/+0.5%), expecting double-digit growth in all international markets outside Greater China, Uniqlo Japan revenue and profit growth (same-store growth 4%), Uniqlo Greater China revenue/profit positive growth.
